 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,
 - 3 SECTION 1. SHORT TITLE.
 - 4 This Act may be cited as the "Commitment to Vet-
 - 5 eran Support and Outreach Act".

1	SEC. 2. AUTHORITY FOR SECRETARY OF VETERANS AF-
2	FAIRS TO AWARD GRANTS TO STATES AND IN-
3	DIAN TRIBES TO IMPROVE OUTREACH TO
4	VETERANS.
5	(a) IN GENERAL.—Chapter 63 of title 38, United
6	States Code, is amended—
7	(1) by redesignating sections 6307 and 6308
8	and sections 6308 and 6309, respectively; and
9	(2) by inserting after section 6306 the following
10	new section 6307:
11	"§ 6307. Grants to States and Indian Tribes to im-
12	prove outreach to veterans
13	"(a) Purpose.—It is the purpose of this section to
14	provide for assistance by the Secretary to States and In-
15	dian Tribes to carry out programs that—
16	"(1) improve outreach and assistance to vet-
17	erans and the spouses, children, and parents of vet-
18	erans, to ensure that such individuals are fully in-
19	formed about any veterans and veterans-related ben-
20	efits and programs (including veterans programs of
21	a State or Indian Tribe) for which they may be eligi-
22	ble; and
23	"(2) facilitate opportunities for such individuals
24	to receive competent, qualified services in the prepa-
25	ration, presentation, and prosecution of veterans
26	henefits claims

1	"(b) AUTHORITY.—The Secretary may award grants
2	under this section to States and Indian Tribes—
3	"(1) to carry out, coordinate, improve, or other-
4	wise enhance outreach activities;
5	"(2) to increase the number of county or Tribal
6	veterans service officers serving in the State or In-
7	dian Tribe by hiring new, additional such officers; or
8	"(3) to expand, carry out, coordinate, improve,
9	or otherwise enhance existing programs, activities,
10	and services of the existing organization of the State
11	or Indian Tribe that has been recognized by the De-
12	partment of Veterans Affairs pursuant to section
13	5902, in the preparation, presentation, and prosecu-
14	tion of claims for veterans benefits through rep-
15	resentatives who hold positions as county or Tribal
16	veterans service officers.
17	"(c) APPLICATION.—(1) To be eligible for a grant
18	under this section, a State or Indian Tribe shall submit
19	to the Secretary an application therefor at such time, in
20	such manner, and containing such information as the Sec-
21	retary may require.
22	"(2) Each application submitted under paragraph (1)
23	shall include the following:
24	"(A) A detailed plan for the use of the grant.

1	"(B) A description of the programs through
2	which the State or Indian Tribe will meet the out-
3	come measures developed by the Secretary under
4	subsection (j).
5	"(C) A description of how the State or Indian
6	Tribe will distribute grant amounts equitably among
7	counties (or Tribal lands, as the case may be) with
8	varying levels of urbanization.
9	"(D) A plan for how the grant will be used to
10	meet the unique needs of American Indian or Alaska
11	Native veterans, elderly veterans, women veterans,
12	and veterans from other underserved communities.
13	"(d) DISTRIBUTION.—The Secretary shall seek to en-
14	sure that grants awarded under this section are equitably
15	distributed among States and Indian Tribes with varying
16	levels of urbanization.
17	"(e) Set-aside.—Of the amounts authorized to be
18	appropriated or otherwise made available for grants under
19	this section for any fiscal year, the Secretary shall ensure
20	that not less then five percent is used to make grants to
21	Indian tribes.
22	"(f) Priority.—The Secretary shall prioritize
23	awarding grants under this section that will serve the fol-
24	lowing areas:

1	"(1) Areas with a critical shortage of county or
2	Tribal veterans service officers.
3	"(2) Areas with high rates of—
4	"(A) suicide among veterans; or
5	"(B) referrals to the Veterans Crisis Line.
6	"(g) Use of County or Tribal Veterans Serv-
7	ICE OFFICERS.—A State or Indian Tribe that receives a
8	grant under this section to carry out an activity described
9	in subsection (b)(1) may only carry out the activity
10	through—
11	"(1) a county or Tribal veterans service officer
12	of the State or Indian Tribe; or
13	"(2) if the State or Indian Tribe does not have
14	a county or Tribal veterans service officer, or if the
15	county or Tribal veterans service officers of the
16	State or Indian Tribe cover only a portion of that
17	State or Indian Tribe, an appropriate entity of a
18	State, local, or Tribal government, as determined by
19	the Secretary.
20	"(h) REQUIRED ACTIVITIES.—Any grant awarded
21	under this section shall be used—
22	"(1) to expand existing programs, activities
23	and services;
24	"(2) to hire and maintain new, additional coun-
25	ty or Tribal veterans service officers; or

1	"(3) for travel and transportation to facilitate
2	carrying out paragraph (1) or (2).
3	"(i) OTHER PERMISSIBLE ACTIVITIES.—A grant
4	under this section may be used to provide education and
5	training, including on-the-job training, for State, county,
6	local, and Tribal government employees who provide (or
7	when trained will provide) veterans outreach services in
8	order for those employees to obtain and maintain accredi-
9	tation in accordance with procedures approved by the Sec-
10	retary.
11	"(j) Outcome Measures.—(1) The Secretary shall
12	develop and provide to each State or Indian Tribe that
13	receives a grant under this section written guidance on
14	the following:
15	"(A) Outcome measures.
16	"(B) Policies of the Department.
17	"(2) In developing outcome measures under para-
18	graph (1), the Secretary shall consider the following goals:
19	"(A) Increasing the use of veterans and vet-
20	erans-related benefits, particularly among vulnerable
21	populations.
22	"(B) Increasing the number of county and
23	Tribal veterans service officers recognized by the
24	Secretary for the representation of veterans under
25	chapter 59 of this title.

1	"(k) Tracking Requirements.—(1) With respect
2	to each grant awarded under this section, the Secretary
3	shall track the use of veterans benefits among the popu-
4	lation served by the grant, including the average period
5	of time between the date on which a veteran or other eligi-
6	ble claimant applies for such a benefit and the date on
7	which the veteran or other eligible claimant receives the
8	benefit, disaggregated by type of benefit.
9	"(2) Not less frequently than annually during the life
10	of the grant program established under this section, the
11	Secretary shall submit to Congress a report on—
12	"(A) the information tracked under paragraph
13	(1);
14	"(B) how the grants awarded under this section
15	serve the unique needs of American Indian or Alaska
16	Native veterans, elderly veterans, women veterans,
17	and veterans from other underserved communities;
18	and
19	"(C) other information provided by States and
20	Indian Tribes pursuant to the grant reporting re-
21	quirements.
22	"(l) Performance Review.—The Secretary shall—
23	"(1) review the performance of each State or
24	Indian Tribe that receives a grant under this sec-
25	tion; and

2	ance publicly available.
3	"(m) REMEDIATION PLAN.—(1) In the case of a
4	State or Indian Tribe that receives a grant under this sec-
5	tion and does not meet the outcome measures developed
6	by the Secretary under subsection (j), the Secretary shall
7	require the State or Indian Tribe to submit a remediation
8	plan under which the State or Indian Tribe shall describe
9	how and when it plans to meet such outcome measures.
10	"(2) The Secretary may not award a subsequent
11	grant under this section to a State or Indian Tribe de-
12	scribed in paragraph (1) unless the Secretary approves the
13	remediation plan submitted by the State of Indian Tribe.
14	"(n) Maximum Amount.—The amount of a grant
15	awarded under this section may not exceed 10 percent of
16	amounts made available for grants under this section for
17	the fiscal year in which the grant is awarded.
18	"(o) Supplement, Not Supplant.—Any grant
19	awarded under this section shall be used to supplement
20	and not supplant State and local funding that is otherwise
21	available.
22	"(p) DEFINITIONS.—In this section:
23	"(1) The term 'county or Tribal veterans serv-
24	ice officer' includes a local equivalent veterans serv-
25	ice officer.
